

**OFFICIAL RULES**  
**THE ULTIMATE HOME FIELD ADVANTAGE GIVEAWAY**  
**FALL 2021**

This giveaway (the “**Promotion**”) is sponsored by Cambria Company LLC, a Minnesota limited liability company (“**Cambria**” or “**Sponsor**”). By participating, you fully and unconditionally agree to abide by these Official Rules. **VOID WHERE PROHIBITED BY LAW. NO PURCHASE NECESSARY TO ENTER OR WIN.**

**WHO MAY ENTER:** Participants must (i) be 18 years or older at the time of entry, (ii) own a residential home located in the United States, and (iii) be a legal resident of the United States or District of Columbia. Employees, officers, and directors of Cambria, its parent companies, affiliates, or subsidiaries, and each of their immediate family members, are not eligible to participate in the Promotion. Void where prohibited by law including, without limitation, residents of Florida and New York.

**HOW TO ENTER:** To enter, eligible participants must fully and accurately complete and submit the applicable entry form located on the website, [www.cambriausa.com/vikings](http://www.cambriausa.com/vikings).

**PROMOTION PERIOD:** Eligible entries must be submitted and received during the promotion period, which begins at 12:01 am on September 23, 2021 and ends at 11:59 pm on Sunday, January 9, 2022 (the “**Promotion Period**”). Only one entry per individual. Entries received before or after the Promotion Period shall not be considered. The odds of winning are not calculable in advance and depend on the number of eligible entries received during the Promotion Period. All eligible entries will be entered into the same pool to potentially win the prizes set forth below. Entrants cannot enter for a specific prize or portion of a prize package. Sponsor reserves the right to reject any entries that do not meet the requirements for participation.

**SELECTION AND NOTIFICATION:** The prize winners will be randomly selected and notified by Sponsor on or around February 1, 2022. Sponsor will utilize the contact information submitted by participant through the entry form. If you fail to respond to Sponsor’s notification and claim the applicable prize within forty-eight (48) hours of being notified, you waive any rights to the applicable prize and Sponsor may randomly select another winner using the same process set forth herein.

**PRIZE PACKAGES:**

- *\$5,000 Cambria Kitchen Upgrade.* One (1) grand prize winner will receive a \$5,000 credit (the “**Credit**”) to be used on certain Cambria quartz products, product fabrication and/or installation services provided by Sponsor or one of its authorized partners. The approximate retail value of this prize is \$5,000. See Credit Redemption Terms below for further details.
- *Cambria Shortboards with Handles.* Twenty (20) winners will each receive one (1) Cambria shortboard with handles in *Princetown*<sup>™</sup> design and matte finish. The approximate retail value of this prize is \$90 each (\$1,800 total). All entrants acknowledge that the winner(s) of this prize will not be permitted to change or alter the design, type, model or color of the shortboards.

Sponsor reserves the right to substitute a different prize package or portion thereof of approximately equivalent value, in its sole discretion. **CREDIT REDEMPTION TERMS & LIMITS.** The Credit (a) must be redeemed within one (1) calendar year measured from the date the prize winner is notified by Sponsor that he or she won the prize, and all unused portions of the Credit shall expire and be forfeited after such date, (b) can only be used on Sponsor’s quartz surface products (i.e. countertops and backsplashes), related fabrication and installation services, and not on any other products, accessories or services offered by Sponsor or its authorized partner(s), and (c) must be used in connection with a kitchen remodel or upgrade at a residential home owned by the prize winner. The prize winner of the Credit will be able to select certain Cambria quartz designs; provided Cambria may exclude certain designs in its sole discretion. Cambria quartz product(s) will be delivered to a Sponsor approved third party partner for fabrication and installation services. While Cambria is under no obligation with

respect to fabrication or installation and such approved third parties are solely responsible and liable for such fabrication and installation services pursuant to an agreement directly between the prize winner and authorized third party, such services shall be provided at no additional cost up to the Credit amount.
